**Description**

**CRJU/LGST 128 – 3 Credits – Civil Rights and Civil Liberties** examines civil rights and civil liberties within the framework of the U.S. Constitution and U.S. Supreme Court decisions. It covers the significant rights provided by the Bill of Rights as interpreted by the courts and the impact of the 14<sup>th</sup> Amendment on equal protection claims. Additionally, administrative, criminal, and civil remedies for civil rights violations are discussed.

**Overall Course Objectives**

Upon completion of this course the students will be able to:

1. identify basic civil rights and civil liberties within American society;
2. describe the U.S. Supreme Court's impacts on civil rights and civil liberties;
3. describe the basic functions and impact of U.S. Supreme Court decisions;
4. compare and contrast the concepts of judicial activism and judicial restraint;
5. summarize the Bill of Rights;
6. identify privacy rights as defined by the U.S. Supreme Court;
7. explain equal protection rights as defined in the 14<sup>th</sup> Amendment; and
8. identify the administrative, criminal and civil remedies for violations of civil rights.
