Description

MORS 102 – 3 Credits -Funeral Service Principles II examines the basic terminology and methodology, responsibilities, and procedures relevant to the role of Funeral Director; covers non-traditional alternatives, funeral practices of the major religious faiths, notification of death, transfer of remains, conduct of the arrangement conference, refunded/preplanned funerals, a cross-section of religious funeral practices, fraternal and military funerals, shipment of remains, cremation, and aftercare. Offered in Spring semester only.

3 credits, 3 lecture hours per week

Prerequisite: MORS 101 with a "C" or better

Overall Course Objectives

Upon completion of this course the student will be able to:

1. determine and identify the primary responsibilities of the funeral director;
2. explain the time frames in which the services of the funeral director are typically provided (i.e. pre-need, at-need, and post funeral follow up);
3. describe and apply proper telephone procedures;
4. explain the techniques for transferring human remains from the place of death to the funeral home using generally accepted procedures and equipment;
5. apply communication skills necessary to meet with a family in the arrangement conference;
6. describe the various major religious funeral customs;
7. describe fraternal and military funeral procedures;
8. discuss with client families prefunded/preplanned funerals;
9. discuss basic expectations for the shipping of human remains;
10. exhibit knowledge of the specific vocabulary associated with funeral service; and
11. explain terminology and considerations unique to cremation arrangements.
