Description

NURN 227 – Nursing Professional Practice Concepts: Students examine the practice of registered nursing. Emphasis is placed on the nursing concepts of evidence-based practice, health policy, leadership and management, professionalism, quality improvement, and safety. Exemplars of professional nursing concepts are explored through active learning and participatory seminars to facilitate progression from student to registered nurse.

Pre-requisites: NURN 129 or equivalent course

Overall Course Objectives

Upon completion of this course, students will be able to:

1. analyze the challenges and stressors associated with transition to the practice of registered nursing;
2. distinguish among the styles and theories of leadership and management essential to professional nursing practice;
3. analyze common problems associated with the health care workplace;
4. contrast elements of evidence-based practice and nursing research related to clinical practice;
5. explain elements of health care policy and ways to advocate for selected health care issues;
6. evaluate quality improvement processes that contribute to optimal health of clients and groups;
7. apply nursing judgment to determine appropriate delegation of nursing care delivery; and
8. evaluate the impact of social determinants of health on health promotion for clients and groups.
